REFUND & CANCELLATION POLICY

A full fee refund, less the administration fee (CAD\$400.00), and application fee (CAD\$200.00) will be granted if IRCC does not issue the Canadian visa. To obtain a refund, the student must provides:

- 1. Original Letter of Rejection from IRSS
- 2. Original Passport if required
- 3. FH International High School Official Letter of Invitation
- 4. Original receipt of the payment
- 5. A Refund Request Form filled and signed by parent/guardian including the name and address of the cheque recipient or wire transfer details

Once all documents are received, the FH Tuition Refund Committee will review it with our Immigration Lawyer and/or verify with IRCC. Once the refund request is approved, the refund will be issued. The total refund review and process time will be proximately 60 days depending on the complexity of the cases.

There will be no refund of the fee in the following circumstances:

- if the student chooses to withdraw for reasons other than the Canadian visa has been denied by IRCC
- if the student is found in violation of FH International High School policies and procedures
- if false or fraudulent information was given and/or not disclosed in the Student Application Form or in any other official documentation.
- if the student got the Canadian visa but was refused to land in Canada or got the Canadian visa suspended by the Canadian authorities.

BEHAVIOURAL CODE:

FH International promotes responsibilities, respect, civility and academic excellence in a safe learning and teaching environment. FH International has developed a Code of Conduct on factors like behavior and attendance that is used to resolve any potential issues. Attendance:

*PLEASE NOTE: According to the Government of Canada: "students must enroll ... and ... pursue studies in Canada. Failure to do so could lead to removal from Canada." - Effective as of July 1, 2014. Students are required to attend all their classes and communicate with their teachers and the school should there be any acceptable reasons for students to be absent. Absences are carefully monitored and students who fail to meet this set of criteria will face discipline and interventions by the Principal and/or Attendance Counselors.

Behavior:

Students are required to follow all aspects of the Code of Conduct, contained in the Student Handbook as well as the Policy documents of FH International. Everyone, including students, parents or guardians, teachers and other staff members are expected to adhere to the Code of Conduct at FH International, whether they are on

school property, on school buses or at school-authorized events or activities. All members of the school community at FH are to be treated with respect and dignity, especially persons in positions of authority. They are expected to use non-violent means to resolve conflict. Physically aggressive behavior is unacceptable. Things like alcohol and illegal drug use, insults, disrespect and other hurtful acts disrupt learning and teaching in a school community.
